

This ticket is a revocable licence issued to the buyer and/or bearer (the “**Holder**”) by Rogers Blue Jays Baseball Partnership (the “**Club**”), owner of the *Toronto Blue Jays* (the “**Jays**”), under the terms set forth below. By using this ticket, the Holder accepts the terms. The Holder is responsible for any violation of the terms of this licence. A violation of this license will give the Club the right to seize the ticket, cancel the associated ticket account and/or refuse admission to or eject the Holder from the “**Stadium**” (which, for the purposes hereof will mean *Dunedin Stadium*, located at 373 Douglas Avenue, Dunedin, Florida, or such other venue at which the *Jays* spring training home game identified on this ticket takes place), in each case with or without refund. The Holder acknowledges that damages may not be an adequate remedy for breach of this license and consents to injunctive or other relief which may be sought to enforce same.

This ticket permits the Holder to enter the publicly-accessible areas of the Stadium at times determined by the Club, attend the *Jays* spring training game identified on the ticket and sit in the seat location identified on the ticket. No credit, exchange or refund will be due or payable by reason only of a game being relocated to a Stadium other than *Dunedin Stadium*. This ticket must be produced upon entry to the Stadium and upon request anytime thereafter to confirm its validity and the Holder’s right to access the Stadium and/or its seating/suite areas during game periods. No re-entry into the Stadium will be permitted. No alcohol, illegal drugs, chemicals, bottles, cans, weapons, large bags, knapsacks or hard-sided coolers or briefcases will be permitted into the Stadium. By seeking entry to the Stadium, the Holder consents to a reasonable search of his/her person and belongings by the Club and/or the Stadium. The Holder agrees not to use language or engage in conduct that is abusive, illegal or objectionable or might otherwise interfere with the game or any ancillary activities or with the reasonable enjoyment of others. The Club reserves the right to change this security policy without notice.

Any sale, resale, assignment or transfer of this ticket, or any of the rights evidenced thereby, in any manner contrary to applicable law or regulation, as well as any attempt at any of the foregoing, is strictly prohibited. Tickets obtained from unauthorized sources may be lost, stolen or counterfeit and may not be honoured. This ticket may not be used for advertising, promotion or any other trade or other commercial purpose without the prior written consent of the Club.

THE HOLDER AGREES NOT TO TRANSMIT OR AID IN TRANSMITTING ANY INFORMATION ABOUT THE GAME, INCLUDING, BUT NOT LIMITED TO, ANY ACCOUNT, DESCRIPTION, PICTURE, VIDEO, AUDIO, REPRODUCTION OR OTHER INFORMATION CONCERNING THE GAME. THE HOLDER AGREES THAT THE CLUB IS THE EXCLUSIVE OWNER OF ALL COPYRIGHTS AND OTHER PROPRIETARY RIGHTS IN THE GAME AND GAME INFORMATION. THE HOLDER GRANTS THE CLUB, THE OPPOSING CLUB AND THEIR AGENTS AND LICENSEES THE UNRESTRICTED RIGHT TO RECORD THE HOLDER’S VOICE, IMAGE AND/OR LIKENESS BY ANY MEANS AND TO USE THE RECORDING(S) FOR ANY PURPOSE, COMMERCIAL OR OTHERWISE, WITHOUT ANY FURTHER PERMISSION OR REMUNERATION.

WARNING: PRIOR TO, DURING AND FOLLOWING THE GAME, BASEBALLS, BATS, BAT FRAGMENTS AND OTHER OBJECTS MAY BE THROWN OR HIT INTO THE STANDS. PLEASE STAY ALERT AND BE AWARE OF YOUR SURROUNDINGS. IF YOU ARE CONCERNED WITH YOUR SEAT LOCATION

PLEASE CONTACT ANY CUSTOMER SERVICE REPRESENTATIVE FOR AN ALTERNATE SEAT LOCATION, SUBJECT TO AVAILABILITY. The Holder voluntarily assumes all risks and danger of any injury or other loss incidental to the sport of baseball (including injury from balls, bats or other objects projected into or within the stands), all associated activities and/or his/her attendance at the Stadium. The Holder releases the Club, the owner of the Stadium (being, in the case of *Dunedin Stadium*, the City of Dunedin, Florida), Major League Baseball (“**MLB**”), the Commissioner of MLB, the opposing club and their affiliates, agents and employees (including players) from any and all liability, regardless of whether such injury or loss occurs before, during or after the playing of the game and whether such injury or loss is caused by any person’s negligence or otherwise.

If Holder’s primary place of residence is in the State of Florida, then these terms will be governed exclusively by the laws of that state and the federal laws of the United States of America applicable therein, and the exclusive venue for any disputes related to these terms or the use of this ticket, including Holder’s attendance at the Stadium, will be the courts of the State of Florida, located in Pinellas County, Florida (for state court claims) or the Middle District in Hillsborough County, Florida (for federal court claims). If Holder’s primary place of residence is anywhere other than in the State of Florida, then these terms will be governed exclusively by the laws of the Province of Ontario and the federal laws of Canada applicable therein, and the exclusive venue for any disputes arising related to these terms or the use of this ticket, will be the courts of the Province of Ontario, located in the city of Toronto.

LIMITED CREDIT/EXCHANGE/REFUND POLICY FOR CANCELLED

GAMES: This ticket bears no cash value. In the event a game is not played or does not progress to or beyond a point of play constituting a regulation game under Official Baseball Rule 7.01 (formerly 4.10) on the date specified on the ticket, then (i) if this ticket was issued as part of a *Full Spring Training Season Tickets* package, the amount paid by the *Full Spring Training Season Tickets* package account holder on account of this ticket will be credited towards such account holder’s 2020 spring training season tickets purchase, or (ii) if the ticket was not issued as stated in (i), this ticket may be exchanged by the original purchaser for a same-priced or lower-priced ticket for any *Jays* spring training home game played at the Stadium within 365 days of the date of the game identified on this ticket, subject to availability. Alternatively, the original purchaser of this ticket may request a refund for the amount paid on account of this ticket by calling the Club’s spring training season ticket office at (727) 733-0429 before 5:00 p.m. on April 22, 2019 and, upon request by the Club, providing this ticket to the Club. Any refund will be processed via the same pay method. **For greater certainty, exchanges and refunds will NOT be issued to the Holder merely upon presentation of this ticket and anyone who purchased this ticket from a source other than the Club must seek any exchange or refund through the party from which the ticket was purchased.** For more information, call the Club’s spring training ticket office at (727) 733-0429.
