Phillies Corporate Party Suites #2, 3, 4, 67, 68, 69, and others are located on DELL EMC Suite Level, which is between Field Level (100 level) and Club Level (200 level). Suites 2 through 4 are on the third base side; Suites 67 through 69 are on the first base side.

Each suite includes a plush, climate-controlled interior lounge area combined with at least 12 open-air seats protected by a roof. The lounge in each suite has catering space along with a high-top table and barstools, two TV's, refrigerator, wet bar, and private restroom. Each suite offers WIFI and a charging station. Your suite number is listed on your Event Invoice.
